LIABILITY RELEASE AND WAIVER AGREEMENT
GRANDPARENTS UNIVERSITY 2024**

I wish to voluntarily participate in Grandparents University® (“GPU”)¹, an intergenerational learning experience on the University of Iowa campus for children aged 8 to 14 who are accompanied by their grandparents and/or older adult relatives. GPU will be held on July 18, 2024, and is a program of the University of Iowa Center for Advancement (“UICA”)

I agree that I am responsible for all children that I register for, and/or who accompany me to, GPU, and I understand that minors cannot attend GPU without a signed Parent/Guardian Consent and Liability Waiver Form and a COPPA Consent Form.

I hereby **RELEASE, WAIVE, COVENANT NOT TO SUE, AND FOREVER DISCHARGE** UICA and all UICA directors, managers, officers, employees, agents, shareholders, members, partners, volunteers, insurers, attorneys, advisors, accountants, parent, affiliates, successors, and assigns (hereinafter collectively “Releasees”) **FOR ANY AND ALL DAMAGES, COSTS, LOSSES, EXPENSES, DEMANDS, CLAIMS, OR CAUSES OF ACTION** for any injury, property damage, emotional distress, or loss of society that is caused, whether directly, indirectly, or consequentially, including as a result of **NEGLIGENCE**, by any of the Releasees and that relates to or arises out of my participation in GPU.

I understand such negligence could include the Releasees’ failure to use reasonable care in, without limitation, selecting, screening, training, or supervising vendors, employees, volunteers, or participants; selecting or maintaining vehicles, equipment or other property used as part of GPU; selecting, approving, or maintaining safety procedures or equipment; providing instructions on the use or selection of equipment; providing other instructions; and/or providing first aid or emergency medical care.

I agree that if any portion of this waiver agreement is held invalid, the balance shall continue in full legal effect.
